NARRATIVE

About 3:32 PM on Monday, December 5th 2022, Officer Taylor in the E435D responded to a radio call for a pedestrian struck at the intersection of Center St and Bellevue St.

Sgt Barrett (E909), Officer Parenteau (ED21) and Officer Robertson (E417D) responded and assisted.

Upon arrival officer Taylor observed a blue Mazda [REDACTED] parked in the right outbound lane with his hazard on and a group of people gathered on the sidewalk. A female later identified as [REDACTED] holding a crying little boy later identified [REDACTED] was complaining for pain in his lower right leg.

Officer Taylor spoke with the operator of the Blue Mazda [REDACTED] stated he thought he had the green light when he observed a child run into the street at which point he slammed on his breaks to avoid hitting the child.

Officer Taylor spoke with several witnesses:

Witness 1: [redacted] stated she observed a motor hit the pedestrian while they were walking on the crosswalk. [redacted] stated the motor vehicle struck the kid on the right front fender side and ran over his right foot. [redacted] stated the child did not roll on the car and the he just fell when he got struck. [redacted] stated she did not observe whether the motor vehicle had a green light or not, and that the motor vehicle was traveling about 5-10 MPH.

Witness 2: [redacted] stated he heard a scream and when she looked she observed the kid on the ground. [redacted] stated she did not observe whether the motor vehicle had a green light or if the crosswalk sign was on, and that the motor vehicle was traveling about 5-15 MPH.

Witness 3: [redacted] stated she was walking with her nephew [redacted] from school. [redacted] stated her nephew [redacted] hit the crosswalk button and when the crosswalk sign came [redacted] started walking when the crosswalk sign showed 9 second. [redacted] stated she observed the motor vehicle execute prior to hitting her nephew.

[redacted] was complaining of pain to his right leg.

Boston EMS A16 arrived and evaluated [redacted] was transported to Children's Hospital for further treatment.
