#### ORDER FOR ENTRY ON PREMISES TO EFFECT LEVY

Geoffrey E. Snyder, Commissioner of the Massachusetts

Department of Revenue, has filed an application seeking an Order authorizing himself and/or his designated agents to enter the premises located at 378 Highland Ave, Somerville, Massachusetts to levy property in satisfaction of unpaid Massachusetts corporate excise taxes, withholding tax, and meals taxes. In support of that Application, the Commissioner filed an Affidavit and Memorandum of Law.

On the basis of the information submitted, the Court finds there is probable cause to believe property belonging to OPA Greek Yeeros Inc. d/b/a OPA Greek Yeeros is located on or within the premises. The property consists of: All assets of this restaurant, including but not limited to all equipment, inventory, furniture, fixtures, cash registers and contents. together with the taxpayer's leasehold, rental and/or other real property interest in the above premises.
