Both parties struggled as the escalator carried them to the up to the next level. 1 Stated BLACKNELL punched him several times in the face and neck, as he continued to maintain a hold of BLACKNELL on the floor, until I arrived on scene.

During a pat frisk of BLACKWELL, a silver colored iPOD was discovered in his front pocket. BLACKWELL immediately stated it was his, even before being asked. I asked Mr. BLACKWELL to identify any song, artist or play list on the device at which time he stated "I don't know what I got on there". Mr. The at that time informed me it was his iPOD BLACKWELL was in possession of. Mr. We has able to provide several songs and artists, specifically telling me there were four (04) Britney Spears songs on the device. I confirmed each artist and song Mr. BUSBY provided me with and returned the device to him.

Boston EMS was dispatched to the station and transported both and and to NEMC Hospital to be treated for their injuries. Mr. The stated he had some neck discomfort and sustained several lacerations to both knees caused by the escalator.

Mr. BLACKWELL was advised he was under arrest for unarmed robbery and assault and batter, and was transported by the C811, to MBTA Transit Police Headquarters to be booked in accordance with department policy and procedure.
