### NARRATIVE

On the above date at 2350 hrs. I , Officer Barriteau received a radio call to respond to Dudley Station for a bus driver assaulted. Upon arrival I spoke with the driver [REDACTED]. The driver stated while operating a route 66 bus (#2299) he stopped at Roxbury Crossing Station to pick up passengers. The driver further stated a female, later id'd as Chantal Williams boarded his bus and stated " I only have this change and your gonna let me ride this bus" . The driver called his dispatch and told them he needed a passenger removed from his bus for refusal to pay the fare. The driver stated at that time Chantal Williams became irate and while departing his bus she threw all the change in her hand in the drivers face. The driver continued his trip to Dudley Station and refused any medical treatment. A bus inspector noticed the suspect ( Chantal Williams) standing at the bus stop in front of the Reggie Lewis Arena. The inspector flagged down a marked Boston Police cruiser and explained to them the situation , in which time they transported the suspect to Dudley Bus Station. Upon arrival at Dudley the driver made a positive id of the suspect and I placed her in custody for ABDW.
