NARRATIVE

- On Friday, December 11, 2009 at apporximatley 1:30pm, I, Officer Candreva, responded to North Station (TD Banknorth side entrance) for an assault in progress. Upon arrival, I observed an MBTA Inspector, later identified as Inspector Gwynn restraining a white male, later identified as Frank Mangini. I learned that Mr. Mangini had attempted to rob another white male, later identified as Mr. [REDACTED]
- Mr. [REDACTED] infromed me while working at the station selling "Spare Change" newspapers in the hallway at the bottom of the escalator of the station (TDBanknorth side), he was approached by Mr. Mangini who asked for money. Mr. [REDACTED] told Mr. Mangini he did not have extra money but did give Mr. Mangini his coffee. Mr. Mangini threw the hot coffee in Mr. [REDACTED]'s face and then placed his hands into Mr. [REDACTED]'s pockets. At that time, Mr. [REDACTED] pushed Mr. Mangini away. Mr. Mangini then punched Mr. [REDACTED] in the face with a closed fist. During the assault, Mr. Mangini took Mr. [REDACTED]'s metal cart and threw it at Mr. [REDACTED] destroying 30 newspapers (approximate value of \$30) and a stereo (approximate value of \$60). Mr. [REDACTED] was able to restrain Mr. Mangini while patrons called MBTA official for help. I did observe a larceration on Mr. [REDACTED]'s face. EMS (A7) responded and treated Mr. [REDACTED] on scene.
- Mr. Mangini was transported by the N823 (Officer Luk and Officer Valles) to MBTA Headquarters for booking. The N720 (Officer Petty and Officer T. O'Connor) also responded and assisted.
- Mr. Mangini was placed under arrest and charged with the following: Assault with
