On 01/07/10 at approximately 9:00pm, MBTA Transit Police Dispatch was notified of an injured passenger who got off MBTA Commuter Rail Train # 137 after the train completed its scheduled station stop at the Lynn MBTA Commuter Rail Station and began to travel north toward Rockport on track # 1.</p> <p>2. MBCR Conductor [REDACTED] as well as other passengers reported the injured party, later identified as Stephen White exited the moving commuter rail train, coach # 1502 in the direct vicinity of the conductor who was in the vestibule of the connected coach # 357. Conductor [REDACTED] was in the process of closing the doors of the train after completing the station stop. Throughout the trip from Boston to Lynn witnesses stated Mr. White was disoriented and moving about the first coach # 1502 of train # 137.</p>

NARRATIVE

MBTA Train # 137 left Boston at 8:30pm and arrived at Lynn Commuter Rail at 8:49pm.

3. After White exited coach # 1502, he lost his footing and fell between the platform and the moving commuter rail train # 137. As a result of the fall White received injuries to his left arm and was subsequently transported by Lynn Fire Rescue to the Mass General Hospital where he was treated and admitted for emergency surgical procedures. Shortly after White fell between the commuter rail platform and train # 137 he was given emergency first aid by passengers who applied a tourniquet to White's left arm to stop the bleeding.

4. The scene was processed by Transit police officers and detectives as well as members from the Transit Police Crime Scene Services. Service was restored to track one of the Rockport line at 11:20pm.
