### Public Narrative

O/S-- On Sunday September 23, 2018 at about 1:53 pm, members of the Youth Violence Strike Force, Officers Connolly, Litterio, and [REDACTED] assigned as the VK15, were on patrol in the area of West Springfield Street in the South End section of the city. While travelling on West Springfield Street toward Washington St., they observed a 2013 Mercedes coupe, color grey, bearing MA registration 9JYK10, double parked on the left side of the street. The vehicle was emitting extremely loud music.

Officers took note of a male standing near the vehicle and two other males standing near the door of 91 West Springfield Street. The officers were operating a black SUV equipped with emergency lights, similar to the dozens of other unmarked black SUV's operated by police throughout the city. The officers pulled behind the double parked Mercedes and upon doing so, saw that both males that were near the door to 91 West Springfield Street took obvious note of the officers' vehicle. Both males then stood, and both were noted to grab onto their respective waists as if securing something, and then turned and entered the foyer area of 91 West Springfield St.

The officers exited their cruiser and followed the males into the building. The officers were dressed in plain clothes with badges displayed and Officer Litterio had on body armor as well. The two males, later identified as Requon Martin and Antoine Mack, entered a first floor apartment. The officers were commanding the males to stop and identified themselves as police. The officers believed that the males may be in possession of weapons, as these officers have made numerous prior arrests for firearms in which the actions of those arrested was consistent with the actions of these men. Illegal firearms are often carried without holsters and are often carried unsecured in the waist area. These officers have seen individuals armed with handguns display the same type of behavior of grabbing their waists, turning away from officers, walking away, or entering buildings in an attempt to avoid police interaction.

The officers reached the door of the apartment and the males attempted to shut the door. Officer [REDACTED] was able to put his left foot between the door and the door jamb and was able to prevent the door shutting all the way. The officers were yelling "police" and to open the door. It was readily apparent to the officers that there was someone on the other side of the door attempting to close it and was struggling against the officers trying to open the door. At one point, the door opened enough for the officers to see inside the apartment, which was extremely dark, having no lights on. At that point, the officers observed a muzzle flash from the interior staircase and also heard the shot as it happened. Officer [REDACTED] felt a stinging sensation to his left leg. The officers then backed out of the doorway and radioed for assistance.

It was later learned that Officer [REDACTED] sustained a gunshot wound to his lower left leg. Within a very short period of time, Antoine Mack exited the building and was taken into custody without further incident. Requon Martin refused to exit the building. A perimeter was set up around

the building and after a period of time and with the assistance of SWAT officers, Mr. Martin agreed to exit the apartment. He was also taken into custody without further incident. It should be noted that at the immediate time that the door was allowed to be opened further was the exact time that the shot was fired at the officers, as if the person holding the door closed let it open far enough for the officers to be exposed.

Officer [REDACTED] was transported to Brigham and Women's Hospital for his wound. Officers Litterio and Connolly were also subsequently transported to B&W hospital for evaluations.

Antoine Mack and Requon Martin were transported to D-4 for interviews and booking. Requon Martin made numerous incriminating statements to Detectives upon being interviewed. As a result, both men to be charged with: Armed Assault with Intent to Murder, Assault and Battery by Means of a Dangerous Weapon to wit: a Firearm, Discharging a Firearm within 500 feet of a Building, Unlawful Possession of Firearm and Ammunition, Carrying a Loaded Firearm.

The apartment at 91 West Springfield Street was frozen pending a search warrant. The Mercedes was towed and held pending a search warrant. Area D-4 detectives to handle search warrant applications and executions.
